**MEMBERSHIP REQUIREMENTS**

1. Each member must hold a CURRENT "FAMILY" MEMBERSHIP in The Family Coach Association and each membership shall be in the name of an individual rather than in the name of the company.
  
2. Each member must own a Prevost Motor Coach and be able to prove ownership to the satisfaction of the club officers with the exception of those qualifying under Paragraph 3. The ownership may be a direct individual ownership of a Prevost or in the form of total or partial ownership of a company that owns a Prevost. Proof of ownership may be required.
  
3. Members as of July 17, 1988 who do not own a Prevost Motor Coach may continue to be members; however, should they purchase a motor coach other than a Prevost they will no longer be eligible for membership.
  
4. Employees of Prevost Car, Inc are eligible for membership and are not subject to the above requirements.
